# Net Metering Changes

bill approved by the Senate last month allows small producers of renewable energy to continue net metering excess power to the Water and Power Authority at full retail price. However, the bill no longer permits net metering for larger producers of alternative power. Payment for "utility-level production" would be limited to a Feed-in

Tariff based on WAPA's costs.

WAPA set up net metering in 2007. Since then, customers who generated their own electricity from solar or wind power and fed excess back into the grid received a oneto-one credit from WAPA. For each kilowatt of power these customers sent to the grid, they got one kilowatt of WAPA power in exchange.

(In 2009, a territory-wide net metering cap of 15MW was set. St. Thomas has not neared its cap of 10MW.)

Because of the cost of infrastructure, WAPA has come up short on the deal.

This new bill, sponsored by Senator Craig Barshinger, stipulates that contributors of between 5kw and 500kw receive a tariff payment amounting to less than the net metering exchange. In this way, WAPA covers its costs. Producers of up to 5kw of electricity can continue net metering, according to the bill.

# Elena Tagini In rofile... Esthetica Day Spa

lena Tagini, owner of Esthetica Day Spa in Frenchman's Bay, came to St. Thomas to visit in-laws 26 years ago. She fell for the island and decided, then and there, to /make it her home. Hailing from Los Angeles, Tagini welcomed island life. She's never

Now, all these years later, Tagini is St. Thomian through and through. As are her husband and two daughters, both raised on island. "I like the simplicity of St. Thomas. It's a melting pot of people who come together," she said. "There are great opportunities here."

One day some 14 years ago, while at a crossroads in life, Tagini admired a spa therapist friend. "You make

people look and feel so good, how lucky you are!" she had said. As fate would have it, the friend needed someone to take over her business. "I went for it!" Tagini said. She attended Esthetics School forthwith and stepped into her new calling.

"When you are doing the right thing in life, everything falls into place," she exclaimed. These days Tagini herself makes clients beautiful. And she loves it.

"Most of us just want to age gracefully," she said. She counsels clients to take good care of themselves. Meanwhile, she and the others at Esthetica help slow down the process.

#### ON THE HORIZON

lans for a UVI medical school have moved front and center. The UVI Board of Trustees gave President David Hall the go ahead for development in April. Shortly thereafter, New Generation Power, a Chicagobased energy company, pledged \$30 million to the endeavor

Dr. Robert Crone came up with the idea. He and his wife, Amanda Pullen, Phd are globally-minded health-care professionals who own Strategy Implemented in Boston and live part-time on St. Croix.

"Our company provides infrastructure for medical education and healthcare provision in many parts of the world," said Pullen. Crone presented his idea to David Hall

'David Hall thought we were from another planet!" said Pullen. But as he considered the benefits for the VI and its healthcare system, he favored the concept.

In 2010, Pullen and Crone introduced Hall to the Dean of Boston University School of Medicine, Dr. Karen Antman, and strategies accelerated.

Boston University has been a great source of advice to UV--in terms of how to develop a medical school," said Pullen. Since 2012, the BU School of Medicine has sent 4th year medical students to Roy Schneider Hospital on

St. Thomas for elective studies. Pullen believes that students from other medical schools will train here, too. Similarly, UVI medical students might one day train in U.S., Puerto Rican, and other Caribbean hospitals.

"You'd get this

tremendous exchange of students and faculty that move around the islands and between the mainland and the

islands," Pullen said.
First, UVI will seek "candidate status" accreditation from the Liaison Committee on Medical Education which only accredits schools in the U.S. and Canada. "None of the other english-speaking medical schools in the Caribbean have a U.S. accreditation," she said. "It's the gold standard."

If UVI gets candidate status, it could start enrolling students as early as 2015-2016.

### Property

The Office of the Lieutenant Governor has detailed seven categories of tax credits available to property owners. If eligible, you are allowed credit for General Homestead and one additional category. (Find applications online at www.ltg.gov.vi). While application deadlines for 2013 and Credits | 2014 bills was May 15th, you can plan ahead for coming years. Specific documentation is required.

**General Homestead:** You must have occupied your home as a primary residence since January of the applicable tax year. Proof of residency via a valid driver's license or voter's registration and a current utility bill are requested. Maximum credit: \$400.

Veterans: If you meet occupancy requirements and have been honorably discharged from the U.S. Armed Services, you qualify. Max credit: \$650.

**Seniors:** You must meet occupancy requirements but may also use this credit for properties held by tenants in their entireties, if either spouse is 60 or older by January 1st of the applicable tax year. Individual annual gross income must be under \$30,000; household AGI must not exceed \$50,000. Max credit: \$500.

Disabled: This applies to property owners who have met occupancy requirements and suffer from a disability as determined by the Social Security Administration by January 1st of the tax year. Max credit: \$500.

Other categories include Visitable Home, Class 1 Inheritance and Tax Credit Circuit Breaker. For details, visit the Tax Assessor's Office at 18 Kongens Gade in Charlotte Amalie. Or call 340-774-2991.
